

Highlights: 2019 Q4 Council Meeting

The College's fourth-quarter Council meeting was held on **December** 7 at the Gardiner Centre, Memorial University, St. John's. Highlights are outlined below.

COUNCIL MEMBERS & LEADERSHIP

Drs. Kevin Hogan, Rebecca Rudofsky, Carl Sparrow, and Tracey Wentzell were returned by voting or acclamation in the recent **Council elections**. They will serve until December 2022. At the Council meeting, Ms. Gail Hamilton and Dr. Elizabeth Bannister were re-elected as **Council chair and co-chair**, respectively.

SPECIAL PROJECTS: PATO AND PPR-NL

Council received a full briefing on two programs that are the focus of much current College effort:

- the **Physician Peer Review (PPR-NL)** project, which will be piloted by volunteer family physicians beginning in January
- the **Physician Asssessment, Training, Oversight (PATO)** program, being developed in association with Memorial University; the practice-ready assessment component (PRA-NL) for international medical graduate family physicians will be the first PATO component developed and implemented

Council was informed that, related to this work, the Deputy Registrar and PATO Medical Director attended a national meeting on physician remediation (Calgary). Similarly, participation in a September conference in Chicago ("Continued Competency: Balancing Assurance and Improvement") confirmed that the **College's efforts align with current thinking on quality assurance/quality improvement programs.**

MATTERS FINANCIAL

The **2020 budget was approved** (\$3.822 million), essentially unchanged over last year.

- Public Engagement: The draft terms for this new committee of Council were reviewed and approved; it will begin its work in the new year


OPERATIONS 2020


ON OUR RADAR PHYSICIAN MOBILITY

Work continues on the regional initiative to find a **"harmonized" approach to physician licensing across the Atlantic provinces**.

The College participated in an information session with NL government officials in November, and a similar meeting of representatives from all four provinces and their medical regulatory bodies is planned for December.

Registrar Dr. Linda Inkpen reported that the College is pleased and encouraged that this work is moving forward, adding that "the College will assist where and when required."

In her update to Council about this initiative, she noted that, if achieved, "regional harmonization can serve as an excellent example of what may be accomplished across Canada. National licensing could have many benefits to Newfoundland and Labrador."
