2021 Q3 COUNCIL MEETING

Council held its third-quarter meeting on September 14, delayed three days by Hurricane Larry. Council and staff members attended both in person and virtually via Microsoft Teams.

Dr. Tanis Adey, the recently appointed College Registrar (her term begins on December 1) also attended as a College Council guest.

An interesting and informative Council session was held on Friday evening, September 10, at which Dr. Adey presented her general vision for continuing College work.

Council meeting highlights follow.

REPORTS PRESENTED

- Complaints: Action and statistics related to the four meetings of the Complaints Authorization Committee (CAC) and two Tribunal hearings that were held in the second quarter were reviewed.
- **Licensing:** Statistics for the first half of 2021 and a progress report on the technical improvements being made for the 2022 licensing renewal process were presented and discussed.
- Quality: Information about the reviews that the Quality Assurance Committee (QAC) administered during the 2021 second quarter was presented, along with information related to the expansion of quality-improvement programming.

 There are currently 13 open cases being overseen by the QAC and the Council's Quality divison.

UPDATES PROVIDED

• Supervision / oversight of provisionally licensed physicians: The protocols for supervision will be reviewed in 2022. A supervision/ oversight fee was introduced on September 1, 2021. This fee is paid by supervised physicians to

- the College, who pays physician supervisors.
- New website: After much work, the revised cpsnl.ca was posted live on September 17. Changes were made in appearance, navigation, content, and in how the site operates technically. Adjustments will continue over the coming months.
- through cpsnl.ca, this portal recieved major attention during the website update. Improvements were made to navigation, functionality, and the number of administrative items available to College registrants. The ability to access Certificates of Professional Conduct applications should be added by this November.
- Financial matters: The College cash flow statements (as of July 31, 2021) were provided to Council for information. The 2022 fee schedule was also reviewed; full details can be found on cpsnl.ca.
- was provided with the status of the **Operations Plan** Q2 2021 and with the College **Risk and Risk-Mitigation Register**. J. Osmond provided an update on the Practice Ready Assessment (**PRA-NL**) program offered by MUN's Faculty of Medicine, Office of Professional and Educational Development. Details of the launch of **PPR-NL** were also presented (see details on next page). In addition, Council approved the College's Strategic Directions and Priorities for 2022.

PPR-NL LAUNCHED

Peer review is vitally important to medical self-regulation. Our province's *Medical Act, 2011*, requires practising physicians to participate in a peer-review program.

The goal of peer review is to ensure that physicians practise safely and competently in a manner that is acceptable to the profession. Peer review can also identify potential areas for improving practices, even those that meet or exceed established standards.


Physician Peer Review (PPR-NL) is the College's new peer review program. It blends traditional quality assurance elements of peer review—patient record reviews and practice visits—with new approaches to facilitating physicians' quality-improvement efforts. It is designed to help physicians focus their own professional development efforts on what will most benefit their patients and practices.

PPR-NL launched assessments in June this year, with an intentionally conservative launch (15 reviews) and scope of physicians involved (community-based Family Physicians). This initial cohort of reviews will help the College understand and assess how physicians may view the principles and mechanics of the process and allow the College to increase operational capacity. The program will expand first to facility-based Family Physicians and then to Specialists.

COVID-19 AND PHYSICIANS' RESPONSIBILITIES

The College reminds physicians that they must not make comments or provide advice—informally, in person, or on social media—that support or encourage the public to act contrary to public health orders and recommendations. **When offering opinions**, physicians must be guided by the law,
